

University of Salamanca Institute of Latin American Studies

This international seminar is a second part that continues the work started in the seminar held at the Pablo de Olavide University (Spain) on November 18, 2021, where cases in Europe were worked on, within the framework of the Urban RED 2021 Conference. The second part deals specifically with cases in Latin America.

To establish the motivation for these activities, we must go back to the year 2016, with the Quito Declaration, when what we could call a new time for urban policies on a global scale begins. The Quito Declaration is the starting point for the materialization in terms of public policies of the SDGs with an impact on urban areas, especially SDG 11, specifically oriented to them, as well as instruments aimed at their materialization, such as urban agendas. The year 2016 marks the culmination of a process that had begun a long time ago, in the 1990s, when what we know today as the Integrated Sustainable Urban Development Model began to take shape from various international spheres such as the EU or the United Nations (MDUSI). Said model constitutes a general framework from which to produce public policies taking into consideration not only their substantive dimension, or content; but also its procedural dimension, or process. Consequently, what the MDUSI promotes is a true paradigm shift in the way interventions in urban areas have to be conceived in the coming years.

At this point, six years after the approval of Quito, we have witnessed the proliferation of a large number of initiatives for the territorialization of the SDGs in urban areas, or the development of more or less complex indicator systems, aimed at know the results derived from the implementation of the SDGs. However, there are fewer efforts from the academy to know the impact of the 2030 Agenda and, specifically, what have been the instruments developed for its application in cities with respect to the way in which they are designed, implemented and evaluated. urban policies. To advance these issues, a group of researchers from universities and research centers in Latin America and Europe have been working since 2021 on a comparative basis, taking national cases with landings on learning and experiences in specific cities. These seminars are part of this research initiative, which is expected to soon bear fruit in an international publication and a long-term work agenda between different researchers from both continents.
